

FINDING MY VIRGINITY  
CANCELLATION, REFUND & TRANSFER POLICY

The following terms apply to the cancellation of reservations for the event “Finding My Virginity” (hereinafter, the “Event”), organized and operated by LATIR LLC, a company incorporated in the State of Florida, United States.

Upon prior notice and mutual agreement, the Finding My Virginity (FMVX) team may assist in identifying a suitable replacement participant. Any transfer must be approved by the FMVX team in advance.

5. Failure to attend or no-show at the Event shall not give rise to any refund or credit. LATIR LLC shall not, under any circumstances, recognize or pay interest or returns on any amounts paid.

6. In the event that the Event is canceled due to causes attributable to LATIR LLC, or due to force majeure or unforeseen circumstances beyond its control, LATIR LLC will refund 100% of the amounts paid within thirty (30) days from the date the cancellation is formally communicated.
